As the insert above indicates, Bennett was hired as a consulting president from 8-Feb-2013 through 30-Mar-2013. He took over for interim president Aubrey Lucas on 1-Apr-2013, or about 4 weeks ago. The agreement paid Bennett \$1,000 per day, with up to \$10,000 in expenses over the 5-6 week period. It is also worth noting that even though the consulting contract began on 8-Feb-2013, it was not signed by either Bennett or IHL commissioner Hank Bounds until 26-Feb-2013.
