New center to focus on regional economic research

Businesses and governmental decision-makers across South Mississippi now have a new resource to go to for timely information about economic trends and issues through a new center in the College of Business.

It is the goal of the newly created Bureau of Business and Economic Research (BBER) to be a contact between the College of Business and the regional business community,

said its director William Gunther, professor of economics.




"The bureau will be a one-stop source of information about the South Mississippi economy and population," said Gunther. "It will provide a structure through which we can focus on ongoing work regarding regional economic policy, economic growth and the economic education of our citizens," said Gunther. While other entities do work in this area, the BBER will pull it all together in one place, he added.

As the excerpt above points out, Doty tapped William Gunther (Professor of Economics) to head the new BBER. The BBER's goal was to "be a contact between the College of Business and the regional business community . . ." As the article states, Gunther described the Bureau as a one-stop source of information about the South Mississippi economy and population, focusing on research on regional economic policy and economic growth.


Our investigators believe they have found one source of the inactivity of the BBER. That source is located near the sunny shores of Pensacola Beach. That source is the University of West Florida.




Investigators at usmpride.com visited UWF's webpages (see above), and accessed the "people finder" that is located in the upper right corner of the main page (see above). That took us to:




At this screen we typed "William Gunther" into the search tool, as shown below:




Next, our investigators "hit" the search button, and found the following:






This page indicates that Gunther's office is located in "Building 53," and "Room 132." That mapping system is given below:




Notice in the center of the screen above that Building 0053 is where "Marketing and Economics" are housed. Yes, it appears to be our own Bill. As the map below indicates, Building 0053 at UWF is the Raymond M. Haas Center, part of the "College of Business Complex":
