## Updated High-Flying Faculty

A Look at High-Dollar Travel Years in the CoB

This report examines "high-dollar," or "extreme" travel years (behavior) among faculty in USM's College of Business. The figures presented here come from Employee Travel Voucher forms, spanning (primarily) from 1995-2005, or roughly a 10 year period. In order to provide some comparison numbers, we provide the following figures for the (approximate) pro-rata share of travel money available in the CoB over time:

1995 --- \$600 2000 --- \$750 2005 --- \$900

In this report, we present travel reimbursements that exceed \$1,250 in a single academic year. Table 1 below contains travel expenditures for several CoB faculty, all exceeding \$1,288 in a single academic year. James Crockett, retired Professor of Accounting, is represented five separate times in Table 1, while Barry Babin, Professor of Marketing, appears four times. The largest single-year reimbursement in Table 1 is \$6,241.87. This amount is applied to Hsieh for the 2003-2004 academic year.

As the Table indicates, Babin averaged about \$2,000 per year across the 1995-1996 and 1996-1997 academic years. This amount is more than three times the annual travel allowance for CoB faculty in the mid-1990s. In all, Babin amassed about \$11,000 in expenditures in just the four academic years represented in the Table below, with the largest single amount being \$4,297.93 in 2001-2002. Hsieh accumulated over \$9,000 in travel spending in just two academic years.

Another interesting feature of the Table above is the number of times the 2002-2003 academic year is represented among the 14 "high-dollar" travel years. That academic year appears seven times across the nine faculty. It appears as though the transition from the Gunther administration to the Doty administration was a costly one for the CoB in terms of travel. It's almost as if CoB coffers were raided in anticipation of tighter future control that was expected from the hiring of an "outside" Dean. Any fears in this regard were apparently unfounded, as documents at usmpride.com show.
