Is Stan Clark Dangeous? Do Dr. Saunders and Dr. Lyman Care?

As one usmnews.net reader noted, <u>Dr. Stephen Bushardt</u> is honored as a Professor Emeritus, even after his (former) wife sought and received a restraining order based on her affidavit of Dr. Bushardt's alcohol abuse, and violent, threatening behavior directed at her and her children.

Two, now former faculty, testified under oath, in Dr. Saunders' presence, about being threatened, berated and assaulted by former Associate Dean Farhang Niroomand. One faculty testified that Drs. Harold Doty and George Carter had to physically restrain Dr. Niroomand to prevent an attack on a colleague. What was her response? Nothing!

Two, now former faculty, testified under oath that Dr. Cherylyn Becker screamed and swore at a secretary – "went ballistic" -- loudly enough that faculty came out of their offices to see what was happening, yet Dr. Saunders did nothing.
