## Cheaper by This Dozen

Twelve Current CoB Faculty USM Dean Lance Nail Could Stand to Lose

Picking up where my recent ranking of CoB faculty that CoB dean Lance Nail can't afford to lose (Behind the 8) left off, this report ranks the top 12 current CoB faculty that dean Lance Nail can't afford to have hang on for an extended period. That is, without these 12 CoB faculty, the CoB's ranking amongst Gulf South business schools would certainly rise higher. Since this list is 50% longer than the last, let's get right to it:

- 12. Elizabeth LaFleur (MKT) LaFleur came to the CoB at the beginning of the Harold Doty administration about six years ago. Given Williams' very poor track-record as interim CoB dean from 2007-08, it couldn't have happened to a better guy.
- **11. Chang-Tseh Hsieh (DS)** Hsieh, currently the CoB's *McCarty Distinguished Professor of Information Systems*, has seen much better days. These days he is either politicking for DS' Kuo Lane Chen to become tenured, or back-dooring other benefits for friends and cronies. He's nowhere near being a top scholar, even in his own unit (decision sciences). That honor now belongs to Fujun Lai. Even DS' Donna Davis' *career* research record placed her above Hsieh in USMNEWS.net's "The Greatest Ever" series. Nowadays, Hsieh is simply in Nail's way.
- **10. - **5. Harold Doty (MGT)** Were he still CoB dean, there is no doubt that Doty would be at the top of this list. As simply a rank-and-file CoB faculty, he's still in the top 5. Number 5 that's no place for someone who had it all just six years ago a PhD from Texas, a spot on the faculty at Syracuse University, and co-authorship connections to some of the best MGT has to offer. - 4. William Gunther (ECO) USM has given Gunther way more than he deserves since retiring from Alabama and joining USM (as business dean) in 1998. At just \$110,000 per year, well below his average earnings at USM since 1998, he's brought home \$1.21 million, and that's all in addition to the loads he's taking from AL's retirement system.
