
# Who Now Holds the Kaetsu Professorship? An Investigation into Missing(?) Supplemental Funds in the CoB

A number of usmpride.com readers have queried regarding the current whereabouts of the Kaetsu Distinguished Professorship in International Business. Some time ago we began an investigation into its whereabouts, and what we have uncovered to date is

#### The Kaetsu Professorship: A Look Back


presented below.

The Kaetsu Professorship appears to have been the result of a relationship between the College of Business at USM and Kaetsu University University (Japan) that began in the early 1990s. According to usm.edu, "Southern Miss and Kaetsu have been academic partners since the early 1990s, exchanging both students and faculty as well as Japanese business executives who visited Hattiesburg to learn about American culture and business practices." # Kaetsu Distinguished Professors: Past and Present

The first holder of the Kaetsu Professorship was Professor Eddie Lewis (Department of Economics and International Business), the person most often cited as establishing the relationship between USM and Kaetsu University. She listed the Professorship along with her educational background, in the *USM Undergraduate Bulletin* beginning with the 1999-2000 edition. That listing is in the center of the screen below:




Upon her retirement after the turn of the century, the Kaetsu Professorhip went into a hiding of sorts, though it was rumored to have been held by H.T. Black (Professor of Economics and former Dean of the College of Business Administration) just before his retirement, possibly as a vehicle for boosting his PERS package. Rumors also circulated that Tim Hudson (USM Provost) held the Professorship at that time. As the screen below indicates, although Black *may have* held the Kaetsu Professorship at that time, he did not list holding the Professorship in the 2004-2005 *USM Undergraduate Bulletin*.


NOT receive a stipend for my Kaetsu activities, just expense money to cover the costs of hosting the Kaetsu president and Simon Clay and to provide some meals and entertainment for Kaetsu students attending the ELI. . . P.S. For the record, Tim Hudson NEVER held the Kaetsu Professorship."



H.T. Black has since retired from USM, and Tim Hudson is now the President of the University of Houston — Victoria. Once again possession of the Professorship is a mystery in the CoB. It has been suggested that Alvin Williams, Professor of Marketing, now holds the Kaetsu Distinguished Professorship in International Business. A check of the most recent *USM Undergraduate Bulletin* did not reveal any useful information in that regard. We did, however, come across an interesting item from USM's Public Relations archives. A representative from Kaetsu University, Simon Clay, visited USM as recently as 2006 to present a \$5,000 check to President Shelby Thames to help support the Hurricane Katrina Relief Fund. As the photo by Steve Rouse shows (see two consecutive screens inserted below), Alvin Williams attended the presentation. Was this in his official capacity as the Kaetsu Distinguished Professor of International Business?

"I did hold the Kaetsu professorship for two years prior to Alvin Williams's appointment, which I believe occurred last summer."



Reporter's Notes, 7/28/2006

H.T. "Ty" Black's response above indicates that he did not receive monetary support during the two years that he held the Kaetsu Professorship. Thus, the Professorship did not affect his PERS classification in any way. Black's response also indicates that Tim Hudson, former USM Provost, has not ever held the Kaetsu Professorship.

Black's response does confirm the stories that he held the Professorship, and for two years. Based on his response, Black held the Kaetsu Professorship during the 2003-2004 and the 2004-2005 academic years. Finally, Black's response also confirms that Alvin Williams, Professor of Marketing (and former Chairman of Marketing, Management and Fashion Merchandising) currently holds the Kaetsu Professorship, and may held it since the Summer of 2005. This confirmation supports the contention that the Kaetsu Distinguished Professorship (1) has been held by two former CoB administrators, back-to-back, and (2) is no longer residing in the Department of Economics, Finance, and International Business. The latter point is important given that the move represents the first time in many years, if ever, that a Distinguished Professorship in the CoB has been moved from one department to another.
