The insert above is taken from documents obtained by USMNEWS.net via a public records request. One of the entries above appears to be a credit assigned back to USM from Enterprise Rent-a-Car, a popular destination for portions of USM's operating budget. This credit is a miniscule \$3.74 from 30-Aug-2011, at least compared to charges to Enterprise of \$124.14 and \$37.74, which occurred on 29-July-2011 and 29-Aug-2011, respectively. These two charges total \$161.88, with a net of \$158.14 after the credit is considered.

Restaurant dining by the Airplane Operations pilots and co-pilots appears to be a key item from the summer-2011 expense report. Pilots Julian Allen, Kenneth Price and/or others dined at Mayflower Seafood Restaurant (\$25.91) on 11-July-2011, Applebees (\$26.84) on 11-July-2011, Parkway House Family

Restaurant (\$30.43) on 12-July-2011, and Burger King (\$10.54) on 13-July-2011. These four July-2011 dining bills total \$93.72. These meals also indicate a July-2011 trip by officials in the Martha Saunders administration to the Greensboro/Concord area of North Carolina. Dining continued in Aug-2011 with meals at the Hyatt Hotel (\$18.95 and \$17.31) on 3-Aug-2011, West Wing Café III (\$17.31) on 3-Aug-2011, Hyatt Hotel (\$33.55) on 5-Aug-2011, Harvey's (\$30.78 and \$19.50) on 24-Aug-2011 and 25-Aug-2011, and Lackie's (\$21.12) on 25-Aug-2011. These seven Aug-2011 dining bills total \$158.52. The meals also indicate that Saunders and others travelled to Washington, D.C. and Columbus, MS. Finally, dining continued in Sept-2011 with meals at Harvey's (\$32.50) on 7-Sept-2011, Gumbo Jeaux's (\$23.08) on 23-Sept-2011, and Café East Humble (\$24.10) on 29-Sept-2011. These three dining experiences come to \$79.68, and they indicate that Aug-2011 trips to Columbus and Houston, TX, were made. They also bring the summer-2011 dining total for the USM pilots/co-pilots to \$331.92.

Lodging for the pilots/co-pilots also came to a whopping sum. Two charges on 13-July-2011 to the Hilton Garden Inn, each of \$178.14, total \$356.28. Two additional charges, these on 4-Aug-2011 to The Broadmoor, total \$426.66 (i.e., \$213.33 each). Other Aug-2011 lodging occurred at the Hyatt Regency (\$501.52) and Holiday Inn (\$174) on 4-Aug and 25-Aug, respectively. As a result, the lodging expenses for summer-2011 come to a staggering \$1,458.46.

Miscellaneous charges to Wal-Mart total \$156.46. Visits to Best Buy and Kirkland's total \$163.96. Charges to Marathon Oil and Chevron total \$29.02. Added to these are interesting charges to Angel Transportation of \$542 (4-Aug-2011), Foreflight of \$249.99 (on 20-Sept-2011) and USM of \$32.98 (on 27-Sept-2011), all of which total \$824.97. These miscellaneous charges total \$1,174.41.

The quick calculations above show that the total found in this report for summer-2011 is a whopping \$3,122.93. This total covers three months (July, Aug and Sept), and produces a hefty monthly average of \$1,040.98. It is important for readers to realize that if Saunders and others used commercial air instead of having the USM plane, these totals above would be avoided, as would the more than \$15,000/month lease payment on the airplane and other expenses associated with the Airplane Operations auxiliary.
