## "Dr. Saunders, You are Cleared for Takeoff"

Another Look at the Expense Associated with Saunders' Plane

I pulled <u>your reader's analysis</u> of USM President Martha Saunders' decision <u>to lease</u> a Beechcraft King Air turbo-prop airplane in 2009, in the midst of multi-million dollar budget shortfalls facing the University, off of your website. I wanted to complete his or her brief analysis of the costs associated with that <u>plane</u>, which was purchased by the USM Foundation and is being leased to USM, is <u>costing</u> Mississippi taxpayers **\$31,500 per month**, based on a 5-year lease (60 months) agreement at **\$1.89 million**.

**Notes:** The "Planegate" amounts are found by dividing \$31,500 (monthly plane lease) by the number of trips taken during the month. The "By Car" amounts are found by multiplying round-trip distances (mapquest.com) by car times \$0.55 (the federal mileage reimbursement rate). The third trips to LaPlace, LA actually involved Hattiesburg and "St. John the Baptist Parish" in Louisiana. That parish's largest city is LaPlace (50% of the Parish's population). The flights were priced using priceline.com, with reservations in coach made one week out from the date of this analysis.

To complete the analysis I added all of the <u>missing trips</u> to the table (Table 1) above. Note that two months (February and March of 2009) of using the president's plane to make just 10 trips cost taxpayers the grand total of \$63,000. Had the trips been made either by car or private air carrier, the taxpayers would have been on the hook for the small sum of \$2,059. That means that the president's preferred mode of travel is costing MS taxpayers \$60,941 more, or 2,959.7% more than the most economical type of travel (car and private air carrier) would have cost. That's a whale of an *extravagance* wrapped up in a single story. Too bad for USM.
