## **Ranking Journals Raises Temps**

journals, if not more. And, at least from what we were told, they were all real. No joke. Of course, real or not (and I presume they are/were), given Klinedinst's outburst a little levity was a welcome addition to that period's attempt at ranking journals. A 1,000-journal list provided that levity in buckets.

Let's turn to last year (2006-07).
