## Additional Agenda Items

New Policies on Dating Undergraduate Students

"Dating an undergraduate student (or students) currently enrolled in one of your own courses is permissible if (1) at least 90% the overall grade in your course is determined by group projects, **and** (2) all group projects for each student are graded by the other members of their group, with no input from the professor."

The proposed policy above is the only one that remains from the batch of dating policies that we voted on in the May CoB faculty meeting. As we wind this process down, I want to again thank the members of the *Ad Hoc Committee on CoB Faculty-Student Relationships* for all of their hard work.
