A number of questions arise with regard to this trip. Aside from Niroomand, Doty, and perhaps Dieth, there were 11 other individuals who attended the Laureate Induction Banquet in Jackson on that May of 2004 evening, all courtesy of USM's CoB. Were these eleven Business Advisory Council members? If so, has the BAC organization's overhead been *under*estimated in a prior commentary ("BAC Equals BAd Charity") available at usmpride.com? Also, if Doty served on the selection committee, did he have to pay to attend the event? Not only does it seem odd Doty was made to pay \$150 to attend, it would seem he would have been allowed the courtesy of having guests accompany him to the event as well.

This document provides an example of the type of spending that the CoB Dean's office routinely engages in. The research team is coming across a number of correspondences between Niroomand and individuals such as Joe Morgan and Barbara Davis that appear to be special requests to gain access to State funds. We are continuing to dig through these.
