Completed Unusual 12-year Tenure Track Stint, Spanning 1979-1984 & 1989-1996

Unusual 12-Year Tenure-Track Stint Spanned a Total of 17 Calendar Years, 1979-1996

Claims to Have Served as the Interim Commissioner of Higher Education of the State of Mississippi, 1987

Appointed Chair of Economics & IB, 1989

Allegedly Phoned Wife of Trellis Green and Tells Her of His Plan to Have Green Fired from USM, ca 1994

Sued by Trellis Green for Violation of Green's Constitutional Rights and "Liberty Interests," 1994

Deposed by Kim Chaze, Legal Counsel to Trellis Green, 1996

Facilitated Economics Professor Edward Nissan's 3-Week Stay in London-then Cyprus-then London, Resulting in Nissan's Absence from the CBA, 1996

Settled Green Lawsuit – Green Awarded Promotion, Raise, Undisclosed Financial Settlement, 1997

Resigned as Chair of Economics & International Business, 1998

Instructed Former USM Sociologist Frank Glamser to Report Findings of Unethical Behavior of Former USM VP for Research, Angeline Dvorak, to Dvorak's Supervisor, former USM President Shelby Thames; Glamser Followed Carter's Advice, a Decision that Resulted in the Employment (at USM) Demise of Glamser and Former USM Donne Scholar, Gary Stringer, 2003

Appointed Chair of Economics, Finance and IB, 2005

Allowed Professor of Economics Edward Nissan to Enjoy Extended Vacation in Lieu of Nissan's Teaching Responsibilities, as Nissan Misses Class Meetings, 2005

Coined Phrase "the faculty member's standard of accuracy" with Regard to SEDONA Information, 2005

Attended only 22.2 Percent of the Meetings of the Council of Chairs, 2005-06

Allegedly Assisted in Plan to Force Economics Professor Franklin Mixon to Resign, 2006

Allegedly Coordinated Negative EFIB Vote on the 3rd Year Review Application of Assistant Professor of Finance Larry Eisenberg, 2006
