## **SEDONA Files**

In an effort to shed more light on the annual evaluation process in the CoB, this is Part XIV in a series of examinations of CoB faculty SEDONA materials, as they appeared on 2 May 2006, or just after the time of the CoB's annual evaluation. One reader has suggested that Carter has the requisite academic credentials to serve as the instructor of record for the business ethics course. In this issue we present Carter's employment and educational background timeline, so that readers can judge for themselves.

The timeline above is odd. According to the data, Carter held tenure-track position(s) in Marine Transportation and/or General Academics at Texas A&M University while holding only a B.A. and M.S. from The University of Southern Mississippi. And, at about the time Carter was promoted to associate professor of General Academics and tenured, both at Texas A&M University, he was awarded a Ph.D. in Economics by Texas A&M University. During part of this period Carter also served as Assistant Dean for Academic Affairs in the Moody College there in College Station.

This track above resembles the reverse of the track taken by former USM VP of Financial Affairs, Greg Lassen, who held that high-level administrative post at USM all while working on a Ph.D. in Economic Development from USM. Lassen is now at UT-Tyler. In this case, Carter held the academic posts at Texas A&M while working on a Ph.D. in Economics (Development?) from Texas A&M. Carter is now at USM.

There is nothing in the table above that indicates, at least to usmpride.com investigators, a credential in ethics for Carter, though he has apparently taught multiple sections of the subject at USM. This aspect of the story seems like the case of Ken Malone, the chair of economic development at USM who has a polymer science background.
