We start by taking a look at assistant professor of international business John Lambert, an individual who has been the subject of usmnews.net reports in recent days. Lambert has taught courses that would qualify as ECO, MGT, IB, BA, FIN/REI, and MAT courses. The list itself is reminiscent of institutions with a "Division of Business" focus, rather than a College of Business structure, and it could reflect a shifting of the guard within USM's College of Business under the new leadership of President Martha Dunagin Saunders. At his 10 April 2007 faculty meeting, USM Provost Jay Grimes was

asked if Saunders intends for the CoB to be primarily a teaching school. Grimes did not refute the possibility, as many in the room thought (hoped) he would.

Next we turn to the SEDONA file of MIS professor Donna Davis, who is also the CoB's SEDONA Coordinator and *new* Assurance of Learning Coordinator for AACSB. Davis' SEDONA vita shows that she has published only **one** (1) refereed article in the 21<sup>st</sup> Century (see below), and that was **5 years ago**. By the time the AACSB Peer Review

Team in 2008, Davis' only refereed article will fall just outside of the 5-year window for AQ status. Why isn't Davis producing more in the area of refereed articles? Well, when she isn't too busy "Coordinating" the output of other CoB faculty, instead of producing her own, she is, like EFIB Chair George Carter and others in the CoB, out working in

private industry. Below you will see all of the "Paid Service" that Davis lists on her SEDONA vita, including the position of Vice President of a software consulting firm:

One final note about Davis' SEDONA file. In the middle of a group of articles published 12 years ago (see above), Davis lists an "(in press)" article at the *Journal of Product & Brand Management*. This is the first piece of evidence in what could be a new AACSB scandal involving the CoB. Is this a 1995 article, or is this article "(in press)" as Davis indicates? The answer is important because under one classification the article counts toward Davis' AQ status, while under the other classification it does not.

Next we turn to the SEDONA file of economics professor Mark Klinedinst, part of which is inserted below. Like Davis, Klinedinst appears to classify a number of older refereed

However, the CoB's AACSB Peer Review Team was in Hattiesburg for only about a day and a half, and was pressed for time in reviewing all of the CoB's research qualifications. It is likely that they glossed over Klinedinst's record and included the two "(in press)" articles as part of his 2001-2006 "AQ window." If this was done, did CoB administrators correct this notation by AACSB officials, or did they "let it go," only to fall in the "mistakes were made" category should the misclassification be discovered? We will continue to investigate this possibility and provide details in future installments of **SEDONA Files**.
