

### Green Discontinues use of "usm.edu" Contact Info for Private Business An Investigative Series on the Use of the CoB for Personal Gain

A recent *Special Report* installment ("Where the Boys Go to School . . .") uncovered tourism management instructor Evelyn Green's use of a USM-provided e-mail address in her private interior redesign firm, Evelyn Kwan Green Interior Redesign. Our reporters have now verified that Green has removed her "usm.edu" contact information from web-based promotional materials regarding her redesign company.

However, a recent check indicates that EFIB Chair George Carter continues to use not only a USM-provided e-mail address as contact information for his private consulting firm, he also continues to use a USM mailbox. Reports of Carter's use of these publicly-provided (subsidized) facilities surfaced at usmpride.com months ago. Our most recent check of the information on Carter's use of these facilities is shown below:

### Commentary

Green's discontinuation of the use of her "usm.edu" contact information arguably represents an admission that use of taxpayer-provided facilities to operate a private business concern is not permissible.
