Hated It!

A Look at the Service Dereliction of the CoB's Interim Dean

Reporters at usmnews.net have received tips indicating that Interim COB Dean Alvin Williams is not living up to his service responsibilities. Table 1 below presents data on the CoB's Graduate Council representatives' presence/absence at Graduate Council meetings over the past two academic years (i.e., 2005-06 and 2006-07). As Table 1 above points out, over the 2006-07 period Interim CoB Dean Alvin Williams, who was at the time a non-administrative-line professor of marketing, missed 6 of the 7 Graduate Council meetings that he was expected, as a CoB representative, to attend. This translates into an attendance percentage of just 14.3 percent. Out of Williams' six absences, only two of these (33.3 percent) were covered by a proxy representative. Among these two occasions, CoH representative Jane Hudson served as Williams' proxy once (50.0 percent). Thus, on that occasion CoB faculty were represented by someone from the College of Health instead of the person elected to serve by those same CoB faculty.

None of the CoB Graduate Council representatives' attendance percentages (over 2005-07) shown in Table 2 above is stellar. Only Charles Sawyer's (former professor of economics) attendance surpassed the 70 percent mark (at 78.3 percent), and even Sawyer's attendance fell to just 60 percent (72.7 percent) in the spring of 2007 (the 2006-07 academic year), when Sawyer was earning \$6,000 (\$12,000) for overload teaching in order to boost his PERS retirement benefits. Former CoB Director of Graduate Progams and former Chair of Management Stephen Bushardt's attendance rate was just over 60 percent. Thus, this report and the recent "Top-Down Ethics" report both show that the CoB gets only "barely passing" (D-level) service effort from Bushardt. Even the CoB's *Graduate Programs Director*, Francis Daniel, provided D-level Grad Council service effort over the period 2005-07 The overall attendance percentage for the CoB's Grad Council representatives (over 2005-07) was a disappointing 65.2 percent.

From what we can tell Williams hates service as much as Gunther does.

¹ This report assumes that Williams was no longer obligated to sit on the Graduate Council after his 10-April-2007 appointment as Interim CoB Dean. Had the two additional meetings been counted, Williams would have been recorded as having eight absences, a figure that produces an attendance percentage of just 11.1, or 1.4 percentage points *below* former CBA Dean William Gunther's Faculty Senate attendance over the 2005-07 period.
