Niroomand Leaving -- A Loss, or a Gain? An Investigative Series on CoB Faculty Research Credentials

The report continues the *Special Report* series on the journal publications that departing CoB faculty take with them when they go. This installment examines the research record of CoB economics professor Farhang Niroomand, who is leaving the CoB before 1-July-09 to become the dean of the School of Business at the University of Houston at Victoria. The results are shown below in Table 1.

According to the results in Table 1 above, Niroomand somewhat "gappy" record consists of 35 journal publications between 1984 and the present. Of these, only two are rated by the CoB's 2008 journal classification as A-level journals. Both of these came in 1998, or more than 10 years ago, and sources tell USMNEWS.net that one of these (*Applied Economics*) was <u>dubiously rated</u> by the 2007-08 CoB Journal Ranking Committee as an A. Twenty one of Niroomand's 35 journal publications are, even using the CoB's journal classifications, rated as either U or --. If these are counted as Ds, then Niroomand's research GPA is *a barely passing* **2.114**, even using what sources describe as the CoB's sketchy standards. As they also conclude, on the research front at least, the loss of Niroomand appears to be the CoB's gain.
