The e-mail from Doty is understandable. Some would say he's just a boy trying to be a Dean. It is highly insulting to Professor Canterbery, who has had, and continues to have, an outstanding career. It is sad to read that the CoB "will be using Dr. Canterbery's visit to generate as much... publicity... as possible..."

Carter refers to Canterbery as a "colleague of distinction," as if there are none in the department at the present time. He also defers to the Dean's plans to use Professor Canterbery as a public relations tool. Some would expect nothing less to be sent from a political appointee.

I have also heard that when Lindley's research record is mentioned in the presence of our esteemed Associate Dean, that Niroomand criticizes relentlessly Lindley's record, based on his idea that Lindley is a "has been." Some would say that Niroomand is a "never was."

The fact of the matter is that both Lindley and Canterbery are colleagues of distinction. Canterbery has "premier" level hits on his record as well, appearing before the first dates on my table above. Let's hope his stay in Hattiesburg is a smooth one, and he never has to hear that Niroomand thinks he's a "has been."
