USM Swarmed by Scandals

Events of the Last 10 Days Have Rocked 100 Year Old Institution

Late on 21-Nov-2011 The Hattiesburg American reported that USM Lady Eagles basketball star Rachel Vigers has been dismissed from the women's basketball team. The dismissal stems from Vigers' 19-Nov-2011 arrest by Pearl River County Sheriff's officials on an intent to distribute marijuana charge that was based on possession by Vigers of about 2 pounds of the illegal drug. Vigers was the leading scorer on last year's edition of the USM Lady Eagles, averaging 16.4 points and 6.5 rebounds per game. Vigers scored 18 points and had 6 rebounds in USM's season-opening victory on 14-Nov-2011. She has not played since that game, and the Lady Eagles are 0-2 since that win.

Vigers' troubles come on the heels of the Martha Saunders' decision to place three high-ranking USM administrators on leave for their potential involvement in a scandal surrounding USM's new Samsung Galaxy Tab 10.1 program. Those administrators are Robert Lyman, USM provost, Homer Coffman, USM chief information officer, and Mike Herndon, the director of procurement and contract services at USM.

As Mary Margaret Halford's 19-Nov-2011 report for The Student Printz indicates, the 700 students who were given new Samsung tablets at the beginning of fall semester 2011 were recently informed by USM administrators that the tablets were not gifts to the students as previously stated, but are instead considered state property that the recipients must relinquish upon graduation or otherwise termination of their studies. USM vice president for student affairs Joe Paul informed these students that "[i]n our excitement and haste, we failed to properly inventory the tablet devices before distributing them to you." USMNEWS.net that Paul's statement is essentially meaningless, given that students were told that the tablet devices belonged to them, not USM. As such, no inventory process would have been needed at the time USM administrators were "excited" about distributing them. In fact, USM Honors College dean David Davies informed Honors College students via e-mail back in August of 2011, the month when this highly controversial (even at that time) program began, that the Samsung tablets were "... yours to keep should you remain enrolled in the Honors College for the 2011-12 year ..." Halford's news story also states that the accounting improprieties involving the Samsung tablets were discovered by USM counsel Jon Mark Weathers via an audit that showed that the devices were purchased with state money. This fact directly contradicts earlier claims (see links above) that the tablets were purchased with private funds, and that state money would be used only to support the consultants. Earlier reports at USMNEWS.net also point out that 1,000 students, not 700, were provided with the devices once Student Government officials and others were added to the program by the Saunders administration.

Meanwhile, Saunders appears to have breezed through this scandal, as there has been no mention of her being put on administrative leave by the IHL. This is so even though her hands are on this scandal, both figuratively, as in the Tweet below, and literally, as in the photo below showing her *excitedly* distributing the devices to various USM students.

USM provost Robert Lyman resigned his administrative post at the beginning of the 14-Nov through 18-Nov work week, a move that sources now state appears to have been an attempt to preempt any link between him and the Samsung tablet scandal. As reported by USMNEWS.net and other outlets, Saunders cited "personal reasons" in accepting Lyman's resignation as provost. Earlier USMNEWS.net reports on Lyman's resignation also mentioned the possibility that Coffman would resign. Coffman was instead placed on administrative leave.
