

## EaglePost, Thank You for the Opportunity

We welcome visitors from EaglePost, among them NutJob-Juggernaut and FingerYouTheFinger-GooGooGooJoob. You asked about J. Robert Coltharp's dog attack. Let me help you with what happened.

I was advised that they shoot such dogs. Pepper spray only makes them more aggressive. And you have to hit them in a small area of the nose and hope the wind doesn't blow the spray back in your face. I have a weapons permit. I qualified as an expert in the Marine Corps. When I was running on an early Saturday morning, I ran past someone who looked as though he was fishing by the Canebrake lake. As I passed him, a dog emerged from the water and immediately charged me. I tried my usual routine but the dog kept charging directly toward me, facing me. J. Robert Coltharp simply stood there and watched his fully grown dog attack me. He had been training it in a hunting routine. Coltharp did absolutely nothing to stop the dog. I backed up as fast as I could all the while shouting at the dog, hoping the dog would stop. It didn't. As it lunged toward me, it was midair directly in front of me in full charge mode, I shot it. It fell to the ground as I fell running backwards. It was a foot in front of me. I could have stood and shot the dog in the head killing it. I did not. I stopped the attack. I'll skip some details and tell you the legal outcome. If you're interested, I'd be happy to provide details and legal documents in support. J. Robert Coltharp lied that his dog did not attack me. I caught him in the lie when we deposed Coltharp's neighbor who testified under oath that Coltharp told him right after the incident that his dog did charge and attack me.
