Why USM-Gulf Coast for Saunders? A Guest Editorial

With the recent resignation of Martha Saunders as USM president, along with her announcement about moving to the USM-Gulf Coast faculty, many at USM are dazed and confused. One of the many questions that keeps popping up concerns not only her decision to return to the USM faculty, a common question in editorials at usmnews, but why she has chosen to join the USM-Gulf Coast campus instead of the main campus in Hattiesburg. I think this particular question is both a legitimate and interesting one, and it is deserving of more from Saunders, the IHL, or someone in a position to provide relevant information to the faculty and staff at USM. I also think I have some good ideas as to why she has made that choice.

I list below some of the answers to this particular question that came to mind when I heard Saunders' announcement. They are presented in no particular order.

It doesn't take a genius to figure out that getting to Gulf Breeze (Pensacola) is much easier from Biloxi or Ocean Springs than it is from Hattiesburg. There are reports on this website explaining that some USM faculty live in locales stretching from Panama City Beach to Mobile and yet are able to drive to the Coast campus when they have to teach a class or two. Saunders' beach house is in between these two. It's a piece of cake . . . really. She'll have her retirement and a high-paying job all at the same time. Mississippi taxpayers will cover the freight.

C. Pretty in Camouflage – For far-away readers, Hattiesburg is a college town. Much of what goes on in Hattiesburg involves USM. The Mississippi Gulf Coast is not a college locale in nearly the same way – it's a much more diverse situation.
